

2021-22 COVID Plan for Mandated Hybrid or Fully Remote

21-22 ERUFSD Remote Instruction Plans

For closures due to COVID related issues

PLAN #1 Sudden Short-Term Remote Instruction

If ERUFSD needed to temporarily close school or specific classrooms due to staffing shortages for an undetermined amount of time.

PK-5:

- With advanced notice, students will bring home their Chromebooks.
- Without advance notice, families will have an option to pick up student Chromebooks from the Elementary main doors between the hours of 9am-12pm in the following manner:
 - 9-10am: Families with multiple PK-5 students
 - 10-11am: K-2
 - 11am-12pm: 3-5
- All students will engage remotely via Zoom and/or Google Meet in ELA and Math instruction daily.
- Additionally, PK-1 will have a website to access for asynchronous learning.
- Grades 2-5 will access their Google Classrooms for daily assignments and the lessons referenced above for both synchronous and asynchronous learning.

MLA/HS:

- Each course will have asynchronous assignments, accessible from their google classroom.
- Each staff member will be assigned (1 or 2) 30-minute “office hour” zoom session(s) per day, as applicable. This schedule will be shared with students via email and each teacher will post the links to zoom on their google classroom page.
- Throughout the day, teachers will also be engaging with students via email, as needed, for individual student support.

Note: We would also use this option if we use up our weather closure days and need a day of instruction back instead of canceling a vacation day.

PLAN #2 Hybrid Instruction

If NYS or DOH mandated a school wide decreased student ratio or an increase in social distancing requirements not sustainable with our current return to learning plan.

PK-5:

- 5 days a week *This plan assumes no full remote option is mandated by NYS*
- Classes may be reconfigured if social distancing were to be mandated at 6’.
- All staff may be utilized to their maximum capacity (i.e., AIS teachers, Special Ed, etc.) as classroom teachers
- All instructional spaces may be repurposed

2021-22 COVID Plan for Mandated Hybrid or Fully Remote

MLA/HS:

- Move to a 2-day in-person / 2-day remote schedule revolving schedule Monday through Friday.
 - Split students alphabetically by last name to assign in-person days
 - Days 1 & 3: A-K
 - Days 2 & 4: L-Z
 - Maintain Master Schedule
 - In-person students will follow their regular schedules and travel from class to class
 - At-home students will check into the beginning of each classroom's instruction remotely via Google Meet / Zoom. They will follow their regular class schedules as prescribed by their teacher.

PLAN #3 Full Remote Instruction

If NYS or DOH mandates a **school wide** closure.

PK-5:

- All students engage remotely via Zoom or Google Meet in ELA and Math instruction daily
- Additionally, PK-1 will have a website to access for asynchronous learning
- Grades 2-5 will access their Google Classrooms for daily assignments and the lessons referenced above for both synchronous and asynchronous learning.

MLA/HS:

- The master schedule will be implemented remotely
 - All students will follow their regular schedules via Google Meet / Zoom.
Instruction begins at the beginning of each period. At teacher discretion, the synchronous lesson may end before the end of the forty minute period for students to engage independently in work from home before their next scheduled class.
